
Swedish-Ukrainian Project Support to Decentralisation In Ukraine 2020-2022



Monthly Flash Report

October 2020

Fiscal Decentralisation

In October, the Fiscal Decentralisation team worked on the following tasks:

- Project experts met with Member of Parliament Mr. Mykysha to discuss the possible changes to the
 Personal Income Tax payment mechanism
- Project experts met with USAID DOBRE colleagues to discuss potential future cooperation
- Project experts met with colleagues from the Gender Related Budgeting (GRB) project to discuss possible dissemination of the GRB outputs once the GRB project closes at the end of this year.
- On 8 October, Project experts took part in the meeting of the decentralisation donor board working group on fiscal decentralisation
- Following the DDB working group meeting, Project experts prepared comments to the draft 2021 state budget

Project experts placed in the Reform Support Office carried out the following activities:

- Range of analyses of the local government financial data (both revenues and expenditures) comparing data for 8 months of 2019 and 2020 with key indicators. Analysis was usually coupled with development of graphic materials to showcase the results
- Participation in the preparation of the monthly report "Monitoring the process of decentralization of power and reform of local self-government" with indicators for 8 months of 2019 and 2020
- Participation in the preparation of the presentation "Peculiarities of the formation of budgets of communities for 2021" for the session of the financial services of the city councils of the AUC (upon request of Minregion).
- Working on the draft Report on the review of state budget expenditures in the part of regional development in terms of supporting the formation of AHs infrastructure (2016-2019)
- Research and preparation of information on the budget process in 2021 for AATC
- Working on the Infrastructure Development Subvention Review Report for the WG working within Minregion







 Providing ongoing support to Minregion with analyses, reports, participation in Working groups and drafting materials for meetings of high level officials

Decentralisation of Education

During October 2020, the work of the education decentralisation team focused on:

- Guidance, support and coaching for Ministry of Education and Science (MES) staff responsible for the education mechanism on:
 - Finalisation of the 2021 version of the MS Excel based subvention allocation tool (Simulator) (approved by the Parliament in the first reading of the State Budget)
 - o Processing of acquired student data for further use in Allocation of the Education Subvention
 - Design of the practical (Macro based) verification tool enabling each school founder to check all essential parameters and statistical data influencing allocation of Education Subvention
 - Development of updates to the Decree of the Cabinet of Ministers No. 1088 dated 27.12.2017 "On the approval of the formula of distribution of the educational subvention between local budgets"
- Continuation of analytical support to MES in design of the structure, composition and approaches to the reform of pedagogical staff salaries:
 - o Finalisation of the case studies on teacher salary reforms in Poland, Estonia and Lithuania
- Support to MES and the Institute of Education Analytics regarding the development and implementation of additional statistical collection modules - Individual Teacher Data, Individual Student Data

Support to Parliamentary Committees

- At the request of the Verkhovna Rada Committee on State Building, Regional Policy and Local Self-Government the Project prepared the following case-study:
 - o Procedure for early recall of elected officials
- Experts continued work on preparation of case studies on:
 - Local government associations

Support to the Association of Amalgamated Territorial Communities (AATC)

- The Project continues to support regional activities of the AATC, in particular holding events of all-Ukrainian scale together with regional branches
- On 1 October, a meeting of the AATC Board and Council took place to discuss elections and coordination of the plans after it
- Strategic support of the AATC: on October 1, a discussion of the integrated project "Improving the quality of life of community residents in rural areas of Ukraine" was held between the leadership of the Association, the DOBRE Program and SKL experts









- On 6 October, the Association participated in the meeting with the local elections monitoring mission of the Congress of Local and Regional Authorities of the Council of Europe
- On 19 October, the Executive Director of the Association took part in the meeting of the Decentralisation
 Donor Board meeting
- Project experts and AATC colleagues worked on the preparation of 2021 work plan
- Project experts took part in the meeting with DOCCU Project and AATC management on cooperation and coordination of activities in the framework of the Education Platform
- Project experts discussed the AATCs communication strategy with the comm manager and the Chernivtsi regional branch
- Project experts conducted 18 need assessment interviews with the AATC Board and Council members in preparation of the 2021 work plan

- Analysis of personal income tax, identification of significant important problems with the PIT collection in 2020, preparation of <u>the analytical report</u>, preparation of materials for <u>the website</u> and social networks
- Analysis of the calculation of the education subvention, identification of problematic issues, discussion with financial experts, preparation and submission of appeals to the IFI, Cabinet of Ministers, the Parliamentary Committee on Budget to prevent the withdrawal of education subvention balances from local budgets
